8.B – Proposed Service Connection Applications for PM-27 and PM-29

The Board was provided an update on the proposed service connection applications with MWD for PM-27 and PM-29. TVMWD has received the official letter from MWD to move forward with the engineering study for both service connections. The district has also received a letter of commitment for co-funding for PM-29 from Puente Basin Water Agency (PBWA). The district will continue to work towards a construction phase with PBWA and Main San Gabriel Basin Watermaster.

8.C – Approve Salary Schedule and Organizational Chart Update – Effective September 9, 2019

Mr. Litchfield reported to the Board that the District's salary schedule and organizational chart require revision and Board approval due to a recent retirement of an employee. As a result of this retirement, the position of <u>Conservation and Resource Analyst</u> was eliminated from the salary schedule and organizational chart. Approval of the updated salary schedule and organizational chart are necessary to remain in compliance with CalPERS and California Code of Regulations Section 570.5.

9. Directors' / General Manager's Oral Reports

Director Goytia – The SGV Council of Governments meeting was rescheduled to October 24, 2019.

Director Bowcock – SCWUA meeting will be held on October 17, 2019. Director Bowcock commended Director Mendoza for taking the T1/T2 test. Director Bowcock attended the SGV Water Forum Committee meeting on October 15, 2019. CA-NV AWWA is asking members to look through historical photos and identify people in the pictures.

Director De Jesus – two new directors were inducted at MWD: Vartan Gharpetian, representing Glendale and Tracy Quinn, representing Los Angeles. The Alliance for Water Efficiency is being co-funded by MWD on behalf of its member agencies beginning in 2020. Director De Jesus also reported that MWD is sponsoring proposed legislation with the State Water Resources Control Board to identify and evaluate drinking water quality constituents of emerging concern since the legislature is trying to set drinking water standards outside the normal USEPA process.

Director Kuhn – reported the federal budget has a line item of \$10-\$30 million for the Water Quality Authority dedicated to groundwater clean-up.

Mr. Litchfield reminded the Board of the upcoming TVMWD Leadership Breakfast on October 31, 2019 and the MWD Solar Cup boat building workshop will be held at TVMWD on Saturday November 2, 2019.

10. Future Agenda Items

President Kuhn requested a performance evaluation for the General Manager in December 2019.
