



ABOUT TVMVD

Three Valleys Municipal Water District (District/TVMWD) is a government agency that was formed by a vote of the people in 1950. It is one of the 26 member agencies of the Metropolitan Water District of Southern California (MWD) that is authorized to deliver wholesale water supplies from the Colorado River and Northern California. The District gets its name from the three areas that it serves: the Pomona, Walnut, and East San Gabriel Valleys. There are 14 cities and water agencies that are within the TVMWD service area, which covers an area of 133 square miles and a population of over 500,000.

The District's annual budget is \$91 million, with the majority of the expenses associated with the purchase and sale of water. A publicly elected, seven-member Board of Directors presides over TVMWD.

They are currently pursuing a degree in Urban Planning, Data Science, Business Administration, Engineering (preferred), Construction Management Technology, or closely related field and are eager to apply their classroom learning to real-world projects.

They bring a willingness to learn, a collaborative mindset, and strong communication skills—both written and verbal. They take initiative, are organized, and enjoy solving problems with a data-driven approach. This individual is excited to support ongoing projects, engage with experienced professionals, and gain meaningful exposure to the technical, operational, and policy aspects of water resource management. They are dependable, adaptable, and ready to contribute to TVMWD's mission of delivering high-quality water in an efficient and sustainable way.

Education & Experience

- Graduation from high school or G.E.D. equivalent.
- Graduation or current enrollment in undergraduate or graduate studies in an accredited college or university with major course work in Urban Planning, Data Science, Business Administration, Engineering, Construction Management Technology, or a closely related field.
- Current enrollment in undergraduate or graduate studies is preferred.
- While no prior work experience is required, preference may be given to individuals with prior related professional work experience and/or students who have completed significantly related coursework.
- Strong attention to detail, exceptional verbal and written communication skills, and proficiency in computer applications such as Microsoft Word and Excel are essential. Experience with other software programs, including AutoCAD and ArcGIS, is preferred.

Physical Demands & Conditions

Requires the ability to receive, understand, and act upon verbal and written communication from others, and to communicate with others. Requires ability to use hands and fingers to handle or feel objects, tools, or controls; to reach with hands and arms; to sit and stand; and to talk and hear. Must be able to carry, push, pull, reach, and lift equipment and parts up to 25 lbs. and heavier weights with the use of proper assistance.

Must be able to participate in job-related activities that requires site visits on varied terrain and exposure to weather that will require operating a motor vehicle.




