C. <u>CLARIFICATIONS</u>

CONSTRUCTION WATER: Construction Water may be obtained by the CONTRACTOR from a
warfhead that District Operations staff will install and connect to the District's new potable water
service. The new potable water service/meter is a 1.5" diameter service. (see photo below). The
District will provide a flow meter and backflow device. The District will not charge the Contractor for
construction water obtained from this location. The Contractor must contact Golden State Water
Company (GSWC) if the Contractor chooses to obtain construction water from a nearby GSWC fire

hydrant. The Contractor may also obtain untreated (surface water) from a District fire hydrant, at no cost, located at the Miramar Treatment Plant, for dust control at the project site.

2. Fieldstone Cladding Materials Sources: A limited quantity of fieldstone required for cladding of the well building and fencing is available at the TVMWD Miramar WTP as seen in the May 4, 2021 prebid meeting walk. It is the Contractor's responsibility to determine the extents of suitable fieldstone rock in the stockpile which meets the specifications requirements for cladding. Contractor is responsible for sorting, washing, and transporting of the stockpiled rock to the well site. The Contractor is responsible or providing additional fieldstone material as needed to complete work should the TVMWD no cost stockpile be insufficient to provide all materials required. See Section 04 43 11 for additional requirements for the fieldstone cladding work and materials requirements.
